**PATIENT INSTRUCTIONS FOR VIDEONYSTAGMOGRAPHY TESTING**

Your physician has ordered a VNG test.  
Follow the instructions below.  
Please call our office at (408) 358-5093 if you have any questions.

- Read, sign, and mail back the Notice of Missed/Cancelled Appointments (attached sheet).
- VNG testing is performed at our Samaritan office only. Phone: (408) 358-5093.
- Arrive 15 minutes early to the appointment to complete paperwork. Please bring the referral sheet with you to the appointment.
- You must have a driver take you home following the test.
- Test time is approximately two hours.
- Do not eat a heavy meal before testing.
- Do not wear make up, facial creams, or any perfume or cologne to the appointment.
- Wear sweats or other comfortable clothing.
- Do not wear a dress or skirt.
- Please **do not ingest** the following for **48 hours** prior to your appointment: **Please consult with your physician prior to any change of medications or drugs you are taking under the care of your physician.**
  - Alcohol
  - Stimulants
  - Marijuana
  - Aspirin
  - Sedatives
  - Medications to treat vertigo (please call your referring physician for permission before you stop taking medications).
- Following testing, the results will be mailed or faxed to your referring physician.
